Cancellation Policy

U-verse TV, Internet: You may terminate new services within 14 days of activation (except as otherwise required by state law) without paying an Early Termination Fee. You are responsible for all fees and charges incurred through cancellation and must return any leased equipment. If you terminate after 14 days (except as otherwise required by state law) and are subject to a term commitment, you must pay service fees and other charges incurred, including an Early Termination Fee. Equipment Return Policy

DIRECTV, U-verse TV and Internet: Upon cancellation all leased equipment must be returned within 21 days to avoid a non-return fee. Non-return fees vary by service: DIRECTV: \$45 per standard receiver and \$135 per DVR receiver; U-verse TV and Internet: up to \$150 per unit.
